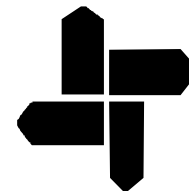

**NOTICE OF AWARD
ASIAN DEVELOPMENT BANK (ADB) FUNDED
SASEC PORT ACCESS ELEVATED HIGHWAY PROJECT
CIVIL WORKS FOR PORT ACCESS ELEVATED HIGHWAY PROJECT**

1. The Democratic Socialist Republic of Sri Lanka has received loan from the Asian Development Bank (ADB) towards the cost of construction of proposed Port Access Elevated Highway (PAEH) Project. Part of the loan will be utilized for construction of Civil Works for Port Access Elevated Highway Project.
2. The Road Development Authority (“the Employer”) invited application for prequalification of bidders for Civil Works for Port Access Elevated Highway Project on 25/09/2017 under eligibility rules and procedures of ADB for the prequalification and the bidding procedures. Following sixteen firms had submitted their application for the prequalification on 06/03/2018.
